2002 Foundation

Safeenat Al Sharq was established in Sharjah, UAE, beginning operations in used-oil collection and storage — marking its first step in the petroleum recycling industry.

2007 First Expansion

Installation of the first bulk storage tanks and tanker truck enabled larger-scale import, export, and distribution for industrial clients.

2013 Laboratory Setup

A modern in-house lab was established for testing density, viscosity, sulfur, and water content, ensuring reliable and compliant fuel supply.

2017 Capacity Growth

Storage capacity expanded to around 1,500 MT with infrastructure upgrades, strengthening the company's regional presence.
